This product may be used on Blue Grass, Fescue, Rye, Bermuda, Bahia, and Zoysia Lawns. DO NOT USE on Dihondra, Carpet Grass and St. Augustine grass. DO NOT USE this product where desirable clovers are present or allow the product to "wind drift" on flowers, vegetables, ornamentals, shrubs, trees or other desirable plants.

This product is designed for control of broadleaf weeds in lawns such as: Bindweed, Black Medic, Blue Lettuce, Buckhorn, Burdock, Chickweed, Chicory, Cinquefoil, Clover, Cocklebur, Croton, Dandelion, Dock, Fanweed, Galinsoga, Goldenrod, Ground Ivy, Hawkweed, Heal-All, Henbit, Jewelweed, Jimson Weed, Kochia, Knotweed, Lambsquarter, Mallow, Morning Glory, Mustard, Nettles, Oxalis, Pennywort, Pepper Grass, Pigweed, Plantain, Poverty Weed, Purslane, Ragweed, Shepherd's Purse, Smartweed, Speedwell, Spotted Spurge, Thistle, Vervains, Vetch, Wild Aster, Wild Lettuce, Wild Radish, and Yarrow.

WHEN TO APPLY: Best results are obtained when weeds are growing rapidly in spring or early fall. IMPORTANT: Apply when grass is moist (after a rain, sprinkling or dew). For most effective broadleaf weed killing action, avoid unnecessary disturbance including watering, of treated areas for 40 hours after application. Watering will wash off weed killing material. Do not reseed for at least 3 to 4 weeks after application. Do not apply to newly seeded or sodded lawn until after 3 mowings.

HOW TO APPLY: This 20 pound bag should be used on 5000 square feet. Apply evenly with a lawn spreader either as one pass application or a two pass application, criss-crossing the area at half the rate each time. Lawns that are heavily overrun by weeds and that are in poor condition may require more than one application of this product. A suggested second application should be made in approximately 30 days.

The following settings are approximate for applying contents of this package at the above suggested rate. Check your spreader on 250 square feet and adjust to apply at the rate of 1 lb. per 250 square feet.

Settings are based on an average walking speed. Reduce setting for slower speed; raise setting for higher speed. Clean spreader thoroughly after use.

STORAGE AND DISPOSAL

STORAGE: Store in original container and keep any bags containing unused product in an area inaccessible to children and domestic animals. Do not store near food or feedstuffs.
