It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

and fungi in recirculating commercial and industrial air wash systems. Upon its use, systems must be cleaned to remove slimes, and other deposits. An initial slug addition of Microbiotrol 99 W fluid ounces of 16 of water to provide a concentration of Microbiotrol 99 W in the system, is recommended. Repeat initial slug additions of 0.47 Microbiotrol 99 W per 100 40 parts per million of Microbiotrol 99 W employed every 2 to 5 days, or as needed, upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the Microbiotrol 99 W air-washing systems that maintain effective flow to its use, systems should be cleaned to remove deposits. An initial slug dose of 7.1 Microbiotrol 99-W is recommended. Repeat initial dosage until concentrations of 4.8 to 11.9 fluid ounces of Microbiotrol 99 W per 1000 gallons of water should be employed. Frequency of addition depends upon the relative severity of the bacterial problem. Slug additions may be made from collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leak-proof drums for disposal. Spills should be absorbed in sawdust or other inert material. Container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this pesticide should be disposed of at a government approved waste disposal facility.

CONTAINER DISPOSAL:
