

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Once a unit has been installed as per instructions, it should be maintenance free and no filter cartridges to replace.

This unit has a capacity of up to 5900 gallons. It is capable of treating 4.5 gallons of cold tap water daily for a period of 36 months. Towards the end of the 36 months (3 years), you will notice a diminishing water flow. This will indicate the filter is nearing the end of its useful life.

This unit should be used with cold water only. The flow rate has been preset at the factory not to exceed 1 gallon per minute.

Installation Instructions:

- 1. Turn off water supply.
- Place unit on water supply at the most convenient location. This is done by cutting the water line. (Note: Use tubing cutter.) Place one end of tubing through brass nut, slide brass ferrule over tubing. Place tubing in the end of unit, holding firm, secure nut on threaded end of unit.
- 3. Place free end of unit in bucket, turn on water supply, allow to run 5 gallons of water. Now turn off water supply.
- 4. Place brass nut over supply line to appliance line, slide brass ferrule over tubing, place tubing into free end of filter. Secure nut and ferrule in place and tighten securely.
- 5. Check both nuts to make sure they are tight. This prevent the COMMENTS I leaking.




