The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act is acceptable subject to the following comments.

- 1. Submit analyses of 5 separate batches to confirm that the certified limits are as requested. See Guideline Reference Numbers 151-13 and 62-1.
- 2. Submit a revised manufacturing process that describes the [I]mprovements in routine commercial production of technical pheromone...(P. 3 Product Chemistry; Certification of Ingredient Limits submitted with your letter of 11/20/90.) See Guideline Reference Numbers 151-11 and 61-2. Please explain the degree of variation in the upper and lower Certified Limits for the active components in your technical. Although we have received Robert Maloney's letters of 3/12/91 and 3/18/91, a complete description of the revised manufacturing process must be submitted in such a way as to comply with PR Notice 86-5.
- 3. Submit a revised Discussion on Formation of Unintentional Ingredients, Guideline Reference Numbers 151-12 and 61-3. In this revised discussion, be sure to explain the large degree of variation in the upper and lower Certified Limits for the impurities in your technical.
