The manufacturing-use product is not for the direct treatment of pests. Do not use from damaged, punctured or unsealed containers. End-use products formulated from this product must be registered by the US EPA. This product can be put to additional uses not listed on the label if the formulator, user group, or grower has complied with US EPA data submission requirements regarding the support of such uses.
