If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

This product is being conditionally registered since the active ingredient (pelargonic acid or nonanoic acid) is currently registered with this Agency in other pesticide products. Also, there is no incremental increase in risk to the environment since the active ingredient in this product is currently registered for application to the same sites in the ammonium form. The Soap Salt RED which covers the ammonium salt of pelargonic acid states that the ammonium salts of fatty acids should pose a minimal threat to endangered species. Since this product is for non-food use, tolerances or exemptions from the requirement for tolerances do not have to be established under the Food Drug and Cosmetic Act.

Although an exemption from the requirement of a tolerance has been established for potassium oleate and related C12-C18 fatty acid potassium salts [40 CFR 180.1068], no exemption or specific tolerance has ben established for pelargonic acid [C9]. Also, an exemption from the requirement of a tolerance has been established for fatty acids, conforming to 21 CFR 172.860, but only as a binder, defoaming agent, or lubricant [40 CFR 180.1001(c)]. For future pesticide food uses, an exemption from the requirement of a tolerance or a specific tolerance must be established. Please refer to the Chemistry Branch I - Tolerance Support and Toxicology Branch II reviews for your temporary tolerance [3G4257] and Experimental Use Permit [53219-EUP-13]. To avoid delay if you request a waiver of fees for filing a petition [40 CFR 180.33], you should pay the appropriate fees first and await EPA's review of your waiver request.


