3. On the submitted CSF, the nominal concentration of the active ingredient, appearing in Column 13(b) should be **consistent with that on product's label, i.e., 99.5%.**

ISOCYANURATE RED ATTACHEMENT A

LABELING: (Statements are based on review of referenced acute toxicity data)

1. The signal word is "DANGER"
2. Revise the Precautionary Statements to read:

CORROSIVE: Causes irreversible eye damage and skin burns. May be fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, protective clothing and rubber gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.

3. Revise the Statement of Practical Treatment to read:

STATEMENT OF PRACTICAL TREATMENT.

IF SWALLOWED: Drink promptly large quantities of water. Do not induce vomiting. Avoid alcohol. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

Decomposes at 460° F to 480° F with liberation of harmful gases.

For repackaging into end-use products intended for use as a disinfectant, sanitizer, bactericide, fungicide or algicide. Repackagers using this product are responsible for obtaining EPA registration of their repackaged products.

STORAGE AND PESTICIDE DISPOSAL

Storage: Keep container tightly closed. Store in a dry place. Do not allow water to get into container.

Pesticide Disposal: Pesticide wastes are acutely hazardous and must be disposed in accordance with applicable Federal and State regulations. Improper disposal of excess pesticide, spray mixture, or residue constitutes a violation of Federal law. If these wastes cannot be disposed of according to the label instructions, contact your State Pesticide, Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.
