- 2. You will make the following label changes before you release the product for shipment:

 - b) Add "...and aquatic invertebrates" to the first sentence under Environmental Hazards.
 - c) Under directions for use add "Formulators using this product are responsible for obtaining USEPA registration for their formulated product which may be labeled for use patterns listed on this label."
 - d) Under the directions for use delete "...and other flying and crawling insects."
- 3. Product Chemistry data requirements for the 830 Series Subgroup A and Subgroup B guidelines are satisfied, except for storage stability (830.6317), corrosion characteristics (830.6320), and oxidation reduction (830.6314). These data are outstanding and must be submitted to satisfy the

requirements of 40CFR 158.190. In addition, samples must be submitted to the EPA analytical laboratory in accordance with Guideline 830.1900. Please refer to enclosed Product Chemistry Review Memo for details.

- 4. Please note that a notice of availability of EPA's reregistration eligibility document (RED) for products containing permethrin was published in the FR on June 28, 2006 (Vol 71 no. 124 pg. 36788). Additional data and/or labeling changes may be required for products containing permethrin.
- 5. Please submit three (3) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

Skintex MRIII-2008B Manufacturing Concentrate is designed to be used with two binding agents, Cognis 3001-A and Cognis 3002-A, along with water. The typical amount of each component in the mixture is 6% Skintex MRIII-2008B, 8% Cognis 3001-A, and 0.3% Cognis 3002-A, with water as the remainder. The specific amount of water used will vary depending on the specific application of the textile mill. Please refer to the Technical Data Sheets provided with the Cognis 3001-A and 3002-A binding agents for exact amounts of products to be utilized when treating individual fabric/apparel types.
