DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Magna Process B307 is used to control bacteria, algae, and fungi in recirculating commercial and industrial air wash systems. To insure its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of Magna Process B307 fluid ounces of 24 of water to provide a concentration of 24 Magna Process B307 per 1000 gallons of water in the system, is recommended. Repeat initial slug additions of 0.73 Magna Process B307 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the supply air-washing systems that maintain effective air flow. To insure its use, systems should be cleaned to remove deposits. An initial slug dose of 11.1 Magna Process B307 per 1000 gallons of water should be employed until control is achieved. Repeat initial slug additions of 7.5 to 11.1 fluid ounces of Magna Process B307 per 1000 gallons of water should be employed until control is achieved. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made in the supply air-washing systems that maintain effective air flow. To insure its use, systems should be cleaned to remove deposits.
