Magna Process B309
in recirculating commercial and industrial water systems must be cleaned to remove algal and other deposits. An initial slug addition of Magna Process B309 per gallon is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 1.1 Magna Process B309 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened and damaged drums should be placed in overpacks. Do not be absorbed in sawdust or sand and dispose of in a container closed when not in use.
