

GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

WATACIDE OS-35 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 1.0 WATACIDE OS-35 per 1000 gallons is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 0.5 WATACIDE OS-35 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Do not store in damaged drums. Drums should be opened in a well-ventilated area. Damaged drums should be placed in overpack and disposed of. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
