GENERAL CLASSIFICATION:**

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

1535 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove sludge growth and other deposits. An initial slug addition of 1.5 gallons of 1535 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 0.5 to 1.5 gallons of 1535 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and should be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely toxic. Excess pesticide, spray mixture, or rinsate is a valuable resource; wastes cannot be disposed of by use according to general household waste disposal practices.
