DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

1541 is used to control mold and fungi in recirculating commercial and industrial air conditioning systems to its use, systems must be cleaned to remove slimes, and other deposits. An initial slug addition of fluid ounces of 1541 per 1000 gallons of water to provide a concentration of 48 parts per million of 1541 in the system, is recommended. Repeat initial dosages of 1.53 to 1541 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the sump of air-washing systems that maintain effective mist to its use, systems should be cleaned to remove deposits. An initial slug dose of 24.7 to 1541 per 1000 gallons of water should be employed each time a collection tray of the airwash system.
