
The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(5), is acceptable provided that you:

<b>Crops</b>	Peaches, nectarines, apricots, plums, cherries and other stone fruits; apples, pears, quince and other pome fruits; almond, macadamia and other tree nut crops.
<b>Target Pests</b>	Oriental fruit moth ( <i>Grapholita molesta</i> ), macadamia nut borer ( <i>Cryptophlebia ombrodelta</i> ), koa seedworm ( <i>Cryptophlebia illepidia</i> )
<b>Rate</b>	Minimum of 100 dispensers per acre (0.96 fl oz or 25.02 gm a.i. per application). Maximum of 200 dispensers per acre (1.92 fl oz or 50.03 gm a.i. per application). Apply maximum rate of dispensers in orchards that are medium to high-risk, such as moderate to heavily infested orchards, or any orchard adjacent to an untreated orchard. Do not exceed 150 gm a.i. (or 600 dispensers) per acre per year.
<b>Application</b>	Place dispensers in lateral branches in upper third of tree canopy. Apply dispensers uniformly in the treated area.
<b>Timing</b>	Apply prior to moth emergence in the spring. In crops with long field seasons, a second application can provide better control. If subsequent applications are required, apply prior to the start of subsequent flights. Consult your local pest control advisor or Pacific Biocontrol representative for proper timing or estimated dispenser longevity in your area.
<b>Note</b>	Isomate-M Rosso suppresses mating of target pests. Immigration of mated female moths of these species from adjacent external sources of infestation will reduce the level of control. Manage by: a. Treatment of external sources of infestation with Isomate-M Rosso. b. Treatment of external sources of infestation with an effective insecticide. c. Treatment of pheromone treated orchard with insecticide. Area-wide application is most effective. Supplementary applications of insecticide are advised when Isomate-M Rosso is used in orchards with high pest populations. All pests must be monitored so that timely intervention with insecticides is possible.
