**TO ACTIVATE FOGGER:** Close all doors and windows. Extinguish all open flames except pilot lights. Remove any pets or animals. Cover exposed food, turn off fans and air conditioners. Place the fogger on a table or on the floor and firmly depress the actuator tab. Do not inhale the fumes; leave the dwelling. May return after one hour. Open doors and windows to clear the air. Leaves no unpleasant odor. For best results on fleas, use in conjunction with Bengal Indoor Flea and Tick Killer.
