FOR USE IN HOUSEHOLDS, SCHOOLS, WAREHOUSES, OFFICE BUILDINGS, THEATERS, GARAGES, HOTELS, MOTELS AND KENNELS

SHAKE WELL BEFORE USE:

TO KILL COCKROACHES, ANTS, CRICKETS, SOWBUGS, CENTIPEDES, SILVERFISH, FIREBRATS AND SPIDERS: Contact as many insects as possible with the spray. Spray along baseboards in the kitchens and baths. Also thoroughly spray all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, crevices, hidden voids under sinks, cabinets and refrigerators and to entry points such as doors, windows, vents, pipes, etc.

TO KILL FLYING INSECTS (mosquitoes, houseflies and gnats): Close space to be treated. Spray above head with a sweeping arm motion 3 feet from surfaces. Spray 10 seconds per 1,000 cubic feet of space. Keep treated areas closed for at least 30 minutes after spraying. Ventilate area before re-entry. Repeat as necessary.

TO KILL FLEAS AND BROWN DOG TICKS: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as necessary. **DO NOT SPRAY ANIMALS.** Old bedding should be removed and replaced with clean, fresh bedding after treatment. Also treat dogs and cats with a flea and tick control product registered for use on pets before allowing them to enter treated area.

Storage: Store in a cool area away from heat or open flame.

Disposal: Replace cap, wrap in newspaper and discard in trash. Do not incinerate or puncture.
