DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

DOSAGE RATES

EVERY THREE MONTHS: 16 fl oz NEW WATER POOL PROTECTOR per 10,000 gallons pool water will prevent algae growth in all pool types.
SEVERE ALGAE TREATMENT: 32 fl oz NEW WATER POOL PROTECTOR per 10,000 gallons pool water.
WINTER DOSE: 16 fl oz NEW WATER POOL PROTECTOR per 10,000 gallons pool water.

GENERAL DIRECTIONS

1. Maintain pool water in the pH range 7.2 to 7.8. Adjust the pH to 7.2 for severe algae.
2. Ensure that filtration system is working properly and that filtration cycle is adequate.
3. A regular brushing program will assist in the removal of stubborn algae.
4. Calculate the volume of NEW WATER POOL PROTECTOR required for your pool.
5. Add the product directly to the pool, distributing it over as wide an area as possible.
6. While NEW WATER POOL PROTECTOR controls algae it is important that adequate levels of sanitizers (chlorine) be maintained to control bacterial growth.
