Amendment Applications Dated January 13, 2011 and February 10, 2011

The amendments referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, are acceptable. The Agency approves the following Amendments to the label:

- Page one Addition of the following alternate brand names, "Pool Frog Value Pack," "Aqua Smarte Value Pack," "Frog Mineral Pac," "Frog Min Pac."
- Page three, addition of the term "{pac}."
- Page four, addition of the following words and/or phrases, "{15,000}, {chlorinator}{feeder}, {shock pac per its label directions}, {Pool Frog Mineral Reservoir}" under the heading Directions for Use with chlorine Bac Pac EPA Reg. No. 53735-2. Addition of the terms "{chlorinator} {feeder}" under the heading Directions for Use with Alternate Source of Chlorine.
- Page six, addition of the phrase "{between 4000 and 9000} {up to 9000}" under the heading Directions for Use.
- Page seven and eight, addition of the phrase "{a start-up spa shock packet}" under the heading Directions for Use.
- Page nine, addition of the words "{pac}, {cartridge} {pac}" under the heading Disposal.
- Page ten, addition of the following:

- o "{Using {algaecide pac} {shock pac} {algaecide and shock pacs} to start up the pool.
 - 1. Remove child proof caps
 - 2. Turn shock pac over and insert into {cycler} {chlorinator} {feeder} before using the Pool Frog Mineral reservoir. {Turn shock pac over and insert in the center of the pool Frog Mineral Reservoir.}
 - 3. Replace cap and run pump until pac is empty.
 - 4. Pull pac up and allow water to drain through {cycler} {chlorinator} {feeder}. Recycle or discard in trash.
 - 5. Wait 24 hours then insert algaecide pac into {cycler} {chlorinator} {feeder} {the center of the Pool Frog Mineral Reservoir.}
 - 6. Replace cap, run pump until pac is empty and remove pac. Recycle or discard in trash.}
- On page eleven, addition of the following words and/or phrases:
 - O Under the number 1, "{chlorinator} {feeder}" and "{how many gallons it will handle.}"
 - O Under the number 2, "{algaecide pac}{shock pac}{algaecide and shock pas}."
 - Under the umber 5, "{Pull up on Bac Pac to {remove}old Reservoir and discard in trash.} {Insert Bac Pac inside new reservoir.} {Push together until parts connect}" and {chlorinator} {feeder}."
 - O Under the number 7, "{Insert FROG BAM into center of reservoir {pushing together until parts connect} and lower into {cylinder}{chlorinator}{feeder}."
 - o Under the number 11, "{chlorinator}{feeder}, {remove} from Reservoir and recycle or."
- On page twelve, addition of the terms "{chlorinator} {feeder}. The Agency also approves the additions of, "{Insert into center of reservoir.} {Push together until snapped in place}" and "container."
- On page thirteen, addition of the terms "{an EPA Registered chlorine shock} {a shock pac}", "{chlorinator} {feeder}", "{Insert an algaecide pac to complete the start-up process. (See pg x for directions.)}", and "{page x}."
- On page fourteen, addition of the phrases, "{with Frog brand Test Strips}", "{color on the test strip matches the ideal Frog range of 0.5ppm to 1.0ppm chlorine.}", "{Before closing the pool for winter, use the {algaecide pac} {shock pack} {algaecide and shock pacs} following the {directions on the pac label} {same directions as pool start up on page x.}", and "{Set wide open.}."
- On page seventeen, addition of the words, "the" and "system." The Agency also approves the addition of the phrase, "{Frog Brand Test Strips to accurately

maintain the reduced 0.5 to 1.0 ppm chlorine level following the label directions carefully.}."

- On page eighteen, addition of the words and/or phrases, "{up to 4000 gallons}", "{For pools up to 98000 gallons, begin on setting 5.}", and "{with the precise Frog Brand-Test-Strips.}".
- On page nineteen, addition of the following phrases, "{or chlorine}", "{a chlorine shock or sodium bromide product}. {For best results use a start-up spa shock packet that quickly dissolves with an effervescent fizzing action one packet per 500 gallons.}", and "{Frog Brand Test Strips to accurately maintain the reduced 1.0 to 2.0 ppm bromine level following the label directions carefully.}".
- On page twenty, addition of the phrases, "{with Frog Brand Test Strips.}", "{color on the test strip matches the ideal {Frog} bromine range of 1.0 to 2.0 ppm.}", "{of offer for recycling.}", and "{with the precise Frog Brand Test Strips.}".
- On page twenty one, addition of the phrase, "{or chlorine}."
- On page twenty two, addition of the proposed language under the heading "Start up".
- On page twenty four, addition of the phrases, "{Use Frog rand Test Strips with the ideal Frog bromine range clearly marked on the label.}" and "{with the precise Frog Brand Test Strips.}".
- On page twenty five, addition of the phrase, "{a spa start-up shock packet.}".
- On page thirty, the Agency approves the additional phrases.
- On page thirty three, the Agency approves the removal of the phrase, "Put the AAAHH in Your Spa."
- On page thirty four, addition of the phrases, "{using the spa start-up shock packet}", "{spa start-up shock packet}", and "Experience the shape of Frog water testing with free Frog Brand Test Strips inside." "Now it's easier to maintain the low 1.0ppm bromine level with Frog Brand Test Strips. See inside for details." "Start-up is easier with the spa start-up shock with its {effervescent} {fizzing} action that shows its working. See inside for details." "Free spa start-up shock packet inside!".
- One page thirty five, addition of the website and # signs.

- On page thirty seven, addition of the phrases under the heading "Copy on rebate coupons" except for the phrase, "Offers an algae protection guarantee when dispensed through the Pool Frog System."
- The Agency approves the proposed labeling claims on pages thirty nine through forty one, with the following exception(s):
 - o The term "better" must be removed from the phrase, "You adopt a better, easier, more fun {pool} {spa} environment."
- The Agency approves the addition of brackets throughout the label.
- The Agency does not approve the use of the term "unconnect" throughout the label as this is not an English word. The Agency suggests the term "disconnect," and would accept its use throughout the label in place of the proposed word "unconnect."
- The phrase "Offers an algae protection guarantee when dispensed through the Pool Frog System" must be removed from page thirty seven as it implies heightened efficacy.

In addition, the Agency requires the removal of the phrases "Frog Mineral {System} {Technology} {Formula} + contains minerals from nature" and "Frog Mineral {System} {Technology} {Formula} + contains silver from nature" from page twenty nine. The Agency acknowledges that these claims were approved on the competitor product label, EPA Reg. Number 67712-5. The Agency has contacted that company and has required the removal of those phrases from the label.

On February 10, 2011, King Technologies, Inc. submitted a Confidential Statement of Formula for the alternate #3 formulation in support of this registration. The alternate CSF, dated February 10, 2011, is acceptable.

A stamped copy of the accepted labeling is enclosed. Submit three copies of your final printed labeling to the Agency before distributing or selling the product bearing the revised labeling.




Diagram B --High Flow Spas in Filter Well






