in swimming pools, exterior spas, whirlpools, hot tubs, minimum effectiveness pools, spas, whirlpools, hot tubs, heavy growth of algae should be cleaned prior to treatment.

For pools having just visible algae growth add _____ fluid ounces of Coastal 781 per 10,000 gallons of water. Subsequent additions of Coastal 781 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of hot tubs, or decorative fountain, add initial dose of Coastal 781 per 1000 gallons of water. Subsequent additions of 1 to 3 fluid ounces should be made every 5 to 7 days after initial treatment.

Coastal 781 is used to treat pools and spas and is not to be used with chlorine chemicals and may reduce the amount of chlorine available. However, do not mix Coastal 781 with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be stored away from food.

DISPOSAL: Do not reuse empty containers.
