in swimming pools, exterior spas, whirlpools, hot tubs, and hot tub effectiveness pools, spas, whirlpools, and hot tubs. Heavy growth of algae should be cleaned prior to treatment.

For pools having just visible algae growth, add Coastal 782 fluid ounces of Coastal 782 per 10,000 gallons of water. Subsequent additions should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains require an initial dose of 1 to 2 fluid ounces per 1000 gallons of water. For treatment of hot tub, or decorative fountain, add initial dose of Coastal 782 per 1000 gallons of water. For treatment of hot tub, or decorative fountain, add initial dose of 0.2 to 0.4 fluid ounces per 1000 gallons of water. Subsequent additions should be made every 5 to 7 days after initial treatment.

Coastal 782 is used to treat pools and spas and is Coastal 782 can contain chlorine chemicals and may reduce the amount of chlorine available. However, do not mix Coastal 782 with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be stored away from food.

DISPOSAL: Do not reuse empty containers.
