

DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide inconsistent with its labeling.

Coastal 784 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 1 Coastal 784 per gallon of water is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 0.5 Coastal 784 per 1000 gallons of water every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Do not store in five drums high. Drums should be opened in a well-ventilated area. Damaged drums should be placed in overpack and should be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes, sprays, excess pesticide, spray mixture, or rinsate is a hazardous waste. Wastes cannot be disposed of by use according to local, State Pesticide or Environmental Control Agency, or representative at your EPA Regional Office for disposal.

CONTAINER DISPOSAL:

- METAL:** Triple rinse (or equivalent). Then recycle, or puncture and dispose of in a container approved by state and local authorities.
