This product is conditionally registered in accordance with FIFRA section 3(c)(7)(A) provided that you:



DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

Coastal 783 is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.9 Coastal 783 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 Coastal 783 per 1000 gallons every 1 to 5 days, or as needed. The frequency and relative amount of bleedoff and the severity of the additions should be made in the sump of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and should be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely toxic. Excess pesticide, spray mixture, or rinsate is a valuable resource. Wastes cannot be disposed of by use according to the Federal Insecticide, Fungicide, and Rodenticide Act. State Pesticide or Environmental Control Agency representative at your EPA Regional Office for guidance.

CONTAINER DISPOSAL:
 METAL: Triple rinse (or equivalent). Then recycle for remanufacturing, or puncture and dispose of in a sanitary landfill, or procedures approved by state and local authorities.
 PLASTIC: Triple rinse (or equivalent). Then recycle for remanufacturing, or puncture and dispose of in a sanitary landfill, or procedures approved by state and local authorities, by burning, if incinerated, allowed by state and local authorities, by burning, if incinerated, no smoke.
