The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the referenced product in connection with the **REDs for Permethrin**, and has concluded that your submission is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

PLEASE NOTE: This product is <u>not</u> being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Your release for shipment of the product constitutes acceptance of these conditions. # **ENVIRONMENTAL HAZARDS**

This pesticide is extremely toxic to aquatic organisms including fish and invertebrates. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. - Do not use in food areas of restaurants or food handling establishments or other areas where food is commercially prepared or processed. Do not use in a facility that is in operation or in serving areas while food is exposed. Serving areas are defined as areas where prepared foods are served such as dining rooms, but exclude areas where food may be prepared or held. When used in the home, cover or remove all exposed food and cooking utensils and cover all food-processing surfaces or wash thoroughly after treatment and before re-use. - 2. Use a clean sprayer. Carefully measure and mix the amount of concentrate and water as directed.
- 3. Spray as directed. Thorough coverage is important. Flush sprayer with clean water after each use. Make applications when insects first appear. Repeat applications as directed.

# Individual Mound and Plant Container Treatment:

Mix ½ fl.oz. in 3 gals. of water and apply as a drench using low pressure application equipment or sprinkler can. Gently apply 1 gallon of the mixture over the surface of each mound. Thoroughly wet mound and surrounding area of 3x4 ft. (12 sq.ft.). For best results apply in cool weather 650-800F early or late in the day. Treat new mounds as they appear. Pressurized sprays may disturb ants and cause migration, which will reduce product effectiveness. Use the same method as above for the control of Fire Ants that may nest in permanently placed containerized ornamentals plants.

On Tent caterpillars, application should be made when caterpillars are young and tents are first noticed. For best results, apply in the late afternoon or evening, when caterpillars have returned to their tents. Wet tents with spray on all sides. A few caterpillars may be seen escaping from the tent; however, they should die within several hours.
