If Swallowed: Call a poison control center or doctor immediately for treatment advice. Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. Do not induce vomiting unless told to do so by a poison control center or doctor.

Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage.

ENVIRONMENTAL HAZARDS



STORAGE AND DISPOSAL

Prohibitions: Do not contaminate water, food or feed by storage or disposal. Do not store under conditions which might adversely affect the container or its ability to function properly. Such conditions include, but are not limited to, positioning of the container in storage, storage temperature, potential for crushing or damage due to stacking, and penetration of moisture. **Storage:** Store in a safe manner.
