In New York State, do make a single repeat application of Bifenthrin GC G if there are signs of renewed insect activity, but not sooner than two weeks after the first application.

Comments

¹Armyworms, Cutworms, and Sod Webworms: To ensure optimum control, irrigate the treated area with up to 0.1 inches of water immediately after application to activate (release from the granule) the insecticide.

²Annual Bluegrass Weevil (*Hyperodes*) adults: Applications should be timed to control adult weevils as they leave their overwintering sites and move into grass areas. This movement generally begins when *Forsythia* is in full bloom and concludes when flowering dogwood is in full bloom. Consult your State Cooperative Extension Service for more specific information regarding application timing.

³Billbugs: Applications should be made when adult billbugs are first observed during April and May. Degree day models have been developed to optimize application timing. Consult your State Cooperative Extension Service for information specific to your region. In temperature regions, spring applications targeting billbug adults will also provide control of over-wintered chinch bugs.

⁴Black Turfgrass Ataenius: Applications should be made during May and July to control the first and second generation of black turfgrass ataenius adults, respectively. The May application should be timed to coincide with the full bloom stage of Vanhoutte spiraea (Spiraea Vanhouttei) and horse chestnut (Aesculus hippocastanum). The July application should be timed to coincide with the blooming of Rose of Sharon (Hibiscus syriacus).

⁵Chinch Bugs: Chinch bugs infest the base of grass plants and are often found in the thatch layer. Irrigate the treated area with up to 0.25 inches of water immediately after application to activate (release from the

granule) the insecticide. Chinch bugs can be one of the most difficult pests to control in grasses and the higher application rates may be required to control populations that contain both nymphs and adults during the summer.

⁶Flea Larvae: Flea larvae develop in the soil of shaded areas that are accessible to pets or other animals. Irrigate the treated area with up to 0.5 inches of water immediately after application to activate (release from the granule) the insecticide.

7Imported Fire ants: Control will be optimized by combining broadcast applications that will control foraging workers and newly mated fly-in queens with mound drenches that will control existing colonies. If the soil is not moist, then it is important to irrigate before application. Broadcast treatments should apply up to 0.4 lb AI/A. Mounds should be treated with an EPA registered product properly labeled for control of fire ant mounds or by applying ½ cup of Bitchthin GC G per mound and then drenching the mound with 1 to2 gallons of water. The mounds should be treated with sufficient force to break their apex and allow the insecticide solution to flow into the ant tunnels. A four-foot diameter circle around the mound should also be treated. For best results, apply in cool weather (65-80°F) or in early morning or late evening hours. Application of 0.25 lbs. a.i./acre of Bifenthrin GC G will provide six months residual activity for control of foraging imported Fire Ants and newly mated Fly-In Queens.

⁸Mole Cricket adults: Achieving acceptable control of adult mole crickets is difficult because preferred grass areas are subject to continuous invasion during the early spring by this extremely active stage. Application should be made as late in the day as possible and should be watered in with up to 0.5 inches of water immediately after treatment. If the soil is not moist, then it is important to irrigate before application to bring the mole crickets closer to the soil surface where contact with the insecticide will be maximized. Grass areas that receive pressure from adult mole crickets should be treated at peak egg hatch to ensure optimum control of subsequent nymph populations (see below).

Mole Cricket nymphs: Grass areas that received intense adult mole cricket pressure in the spring should be treated immediately prior to peak egg hatch. Optimal control is achieved at this time because young nymphs are more susceptible to insecticides and they are located near the soil surface where the insecticide is most concentrated. Control of larger, more damaging, nymphs later in the year may require both higher application rates and more frequent applications to maintain acceptable control. Applications should be made as late in the day as possible and should be watered in with up to 0.5 inches of water immediately after treatment. If the soil is not moist, then it is important to irrigate before application to bring the mole crickets closer to the soil surface where contact with the insecticide will be maximized.

¹⁰Ticks: Do not make spot applications. Treat the entire area where exposure to ticks may occur. Use higher application rates when treating areas with dense ground cover or heavy leaf litter. Ticks may be reintroduced from surrounding areas on host animals. Retreat as necessary to maintain adequate control. Do not allow public use of treated areas during application.

Deer Ticks (*Ixodes sp.*) have a complicated life cycle that ranges over a two-year period and involves four life stages. Applications should be made in mid to late spring to control larvae and nymphs that reside in the soil and leaf litter.

American dog ticks may be a considerable nuisance in suburban settings, particularly where homes are built on land that was previously field or forest. These ticks commonly congregate along paths or roadways where humans are likely to be encountered. Applications should be made as necessary from midspring to early fall to control American dog tick larvae, nymphs and adults.

Perimeter Application: Apply to ground area 5 to 10 feet wide around and adjacent to the structure.

Broadcast Spot Applications: For the control of actively foraging ants (including Imported Fire Ants) broadcast uniformly 2.3 to 4.6 lbs. Bifenthrin GC G per 1000 sq. ft. (0.2 to 0.4 lbs. AI/Acre). See comments section under Grass Applications for additional rate recommendations.

Pad Mounted Electrical Sites: To reduce or prevent ant mound building activity on electrical pads, uniformly distribute 1.0 to 1.5 Tablespoons (0.06 to 0.09 lbs.) of Bifenthrin GC G per 4 sq. ft. of mounting pad. Where existing transformers are completely or partially filled with soil excavated by resident Ants, remove any excess fill and level the remaining soil prior to application. Food utensils such as tablespoons must not be used for food purposes after use in measuring pesticides.

Note: Electrical transformers appear to be more attractive to ants during the cooler months. For best results treat in the Fall or early Spring.

Dear Sir or Madam:

Enclosed is a Notification for a correction per (PR) Notice 98-10. Item 2b on the Agency Notice of Registration dated 10-09-03 says that "On page 5 footnote #7 ("Imported Fire Ants"), add "(EPA Reg. No. 53883-124)" after the product name Bifenthrin PL Granular," which is confusing to the consumer. The revision should say "Replace Bifenthrin PL Granular with Bifenthrin GC G," which is the product that the statement is referring to. We in no way intended to direct the end user to use another registered product for this application.

The reason that item 2b on the Agency Notice of Registration dated 10-09-03 exists at all is because we made a typographical error when we called it "Bifenthrin PL Granular" in the label originally submitted. The typographical error occurred as a result of copying and pasting text from another approved label that we own which has the same use directions.

Please see highlighted text on page 5 of attached labeling.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 USC Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
