Do not apply this product through any other type of irrigation system. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system.

Crop injury, lack of effectiveness, or illegal residues in the crop can result from nonuniform, distribution of treated water. With the exception of the crops listed below, rotational crops may not be planted within 30 days after last application.

#### Tank-Mixture

Cyper AG II II may be applied in tank mixtures with other products approved for use on cotton, brassicas, bulb vegetables, head lettuce, and pecans. Observe all restrictions and precautions which appear on the labels of these products.

For improved control of aphids and mites on cotton, Cyper AG II II may be tank-mixed with Curacron® 8E. The tank-mixture is most effective when pest populations are first observed. Subsequent applications may be needed to maintain control.

#### **Spray Drift Precautions**

Do not make more than 10 synthetic pyrethroid applications (of one product or combination of products) to a cotton crop in one growing season. Synthetic pyrethroid products include Ambush®, Ammo®, Asana® XL, Baythroid®, Capture®, Danitol®, Fury®, Karate®, Mustang, Scout® X-Tra, and Warrior®.

All aerial and ground application equipment must be properly maintained and calibrated using appropriate carriers.

OBSERVE THE FOLLOWING PREAUTIONS WHEN SPRAYING IN THE VICINITY OF AQUATIC AREAS SUCH AS LAKES; RESERVOIRS; RIVERS; PERMANENT STREAMS, MARSHES OR NATURAL PONDS; ESTUARIES AND COMMERCIAL FISH FARM PONDS.

Do not apply by ground equipment within 25 feet, or by air within 150 feet of lakes; reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries, and commercial fish farm ponds. Increase the buffer zone to 450 feet when ultra low volume (ULV) application is made.

For aerial applications, the spray boom should be mounted on the aircraft so as to minimize drift caused b wingtip or rotor vortices. The minimum practical boom length should be used and must not exceed 75% of wing span or rotor diameter.

Use the largest droplet size consistent with good pest control. Formation of very small droplets may be minimized by appropriate nozzle selection, by orienting nozzles away form the air stream as much as possible, and by avoiding excessive spray boom pressure.

Spray should be released at the lowest height consistent with pest control and flight safety. Applications more than 10 feet above the crop canopy should be avoided.

Make aerial or ground applications when the wind velocity favors on target product deposition (approximately 3 to 10 mph). Do not apply when wind velocity exceeds 15mph. Avoid applications when wind gusts approach 15 mph.

Risk of exposure to sensitive aquatic areas can be reduced by avoiding applications when wind direction is toward the aquatic area.

Do not cultivate within 10' of the aquatic area so as to allow growth of a vegetative filter strip.
