c. Delete the statements "Humans, For Animal Use Only, and Not for Use on Humans" and move the statements, "Avoid contact with eyes or mucous membrane and Avoid contamination of food." under Directions for Use, second paragraph.

d. On the front panel delete "Gentle, Sweat and water resistant fly repellent formula", "Repels & Kills Deer Ticks that may cause Lyme Disease", "Up to 28 days Fly Control", and "Won't sweat off". No data was submitted to support these optional marketing claims.

e. Change "Protects against Biting & Nuisance Flies, Gnats, Mosquitoes, Deer Ticks and Lice" to "Protects against Biting & Nuisance Flies, Gnats, and Mosquitoes (culex spp)". No data was submitted to support deer ticks and lice.

f. Based on the submitted data change "Ready- touse, Cyper 1% Horse Spray insecticide/repellent/formula provides repellency, quick knockdown and long lasting protection from flies, gnats and mosquitoes. g.
