The application referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following comments:

1. Increased duration (the current label states reapply every 5-7 days)

a. Claims of up to 14 days for fly control are acceptable provided you agree to perform an additional stable fly study. These data are required because the submitted study showed that the product was only marginally effective. We suggest that to complement the already submitted data you use lab reared stable flies that can be held against the horse in an enclosed container. Many replicates can be performed over time.

b. For horses and ponies (not a new claim) is acceptable.

c. Field tested and proven effective is acceptable.

d. Long-lasting repellency that protects and stays active for up to 14 days. Is acceptable.

e. 14-day protection is acceptable.

f. 24/7 (fly) (biting fly) [mosquito (*Culex* spp.) protection is not acceptable. You must state length of protection.

g. 24/14 fly control [protection]. is not acceptable. You must state length of protection.

h. Works day and night is acceptable.

i. For use on horses and ponies is acceptable.

2. Weather, water and sweat resistance (these types of claims were not acceptable in former submissions)

a. Weatherproof formula binds to the hair shaft to repel and protect from bugs, sun, sweat, water, dust, and dirt for up to 14 days is not acceptable

b. Sweat resistant fly spray is acceptable.

c. Sweat and water resistant fly repellent formula is not acceptable.

d. Won't sweat off is acceptable.

e. Sweat resistant fly spray is acceptable.

f. Sweat and water resistant fly repellent formula is not acceptable.
