 - a. Add the designation: EPA Reg. No. 53883-203.
- b. Limit the use on the listed sites to the treatment of ant mounds for fire ant and harvester ant control by qualifying the use to read as follows: For use on home lawns and around ornamental plantings as an ant mound treatment only and only for fire ant and harvester ant control.

c. Add the use restriction cited below so that the use sites are consistent with those appearing on the supporting product label and to ensure that the product is not used for those uses within the scope of the Worker Protection Standard; i.e. plants grown for agricultural or commercial use.

For outdoor use around the home only.

d. Based on the information submitted and data available for the supporting product, the efficacy claims cited below are not acceptable and must be removed from the label.

"Fast acting", "quick knockdown", "within hours", and "in hours"

e. Correct the sentence "Applications made during prolonged hot or dry conditions may be less effective." to read as cited below.

Applications made under prolonged hot and dry conditions may be ineffective due to location of ants deep in the nest.

f. Correct the sentence, "Do not allow children or pets to come into contact with treated surfaces until dust have settled." to read as cited below.

Do not allow people or pets to enter the treated areas until dusts have settled

g. Revise/expand the human precautionary statements section so that it reads as cited below.

Please note that based on the acute toxicity profile of the product, the human precautionary statement "Avoid breathing dust." and the word "skin" in the statement "Avoid contact with eyes, skin, and clothing" are not required and may be removed at your option.

Harmful if swallowed. Cause moderate eye irritation. Avoid contact with eyes and clothing. It is understood that the basic Confidential Statement of Formula (CSF) dated July 13, 2006, is the correct basic CSF for the product, subject to the correction of the typographical error cited in your e-mail of September 20, 2006. The basic CSF dated September 20, 2006 was found to be incomplete and is unacceptable. Columns 14 a and b were not completed for the second listed ingredient.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For use on home lawns and around ornamental plants (including flowers, trees, and shrubs).

Acephate 50 Fire Ant Insecticide provides quick knockdown and kills fire ant workers in hours. Colonies are destroyed within 3 to 7 days. The powder is tracked into the mound by the worker ants where it also kills the queen, and destroys the mound.

[Optional directions to open cap-

[For Cutting Fin Type Cap

Do not shake package. Squeeze cap sides while unscrewing. Squeeze hard. To open inner seal, aim away from body. Invert cap and press down on seal to puncture. Rotate cap a quarter turn (1/4) while pressing down to cut open the seal. Remove inner seal.]

[For dome type cap

Do not shake package. Press down on dome and hold to puncture inner seal. Squeeze cap sides while unscrewing. Remove and dispose of inner seal.]

[For tear seal type cap

Do not shake package. Squeeze cap sides while unscrewing. Inner seal will tear when opened.]

To kill Fire Ants and Red Harvester Ants in home lawns and around ornamental plantings:

Sprinkle 1 tablespoon (3 teaspoonfuls) dry powder over each mound. Do not water in. Treat new mounds as they appear.

For best results, apply when ants are active. Applications during prolonged hot or dry conditions may be less effective. Try not to disturb mounds while treating. Do not apply during a heavy dew or just before a rain. Repeat treatment if ants reappear.

Do not allow children or pets to come into contact with treated surfaces until dusts have settled.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Keep pesticide in original container. Store in a cool, dry place, preferably in a locked storage area.
