

Apply 1 to 2 ounces per day with a soft cloth or as a fine spray mist.

#### **Application as a Wipe On:**

- Thoroughly brush the horse to remove any loose dirt and dust.
- Moisten a soft cloth (do not wet to the point of dripping) and rub all over the horse hair. For best results, rub against hair growth.
- Make sure to apply to legs, shoulders, shanks, neck and face where flies are most attracted.
- Thoroughly brush out the hair after application for a lustrous sheen.

**Note:** Make only a light application. Do not wet the skin. May be used daily or as required.

#### **Application as a Spray:**

Apply CSI Wipe & Spray as a fine mist to the stable area and around stabled horses to quickly kill flies.

**Note:** Do not wet horse's skin. Do not exceed two (2) ounces per application.
