 - a. Revise the EPA Registration Number to read, "EPA Reg. No. 53883-272"
 - b. In the "Restricted Use Pesticide" box, revise to read as follows: "For retail sale to and use only by Certified"
 - c. In any marketing statements or use directions throughout the label, any claim or direction against imported fire ants must be followed by the species designation, *"Solenopsis* spp."
 - d. In the DIRECTIONS FOR USE statement, add the following text after the first sentence of the statement: "**RESTRICTED USE PESTICIDE**".
 - e. Add the following statement to the beginning of the "PESTICIDE STORAGE" statement within the "STORAGE AND DISPOSAL" statement: "Do not store in or around the home."
