FIRST AID

- Do not apply as a broadcast treatment to indoor surfaces at residential sites, including nurseries, day-care centers, schools, hospitals, and nursing homes.

SHAKE WELL BEFORE USE

CSI Aerosol Flea Killer and Insect Growth Regulator is produced to kill adult fleas and prevent flea infestations for up to 7 months. Adult fleas may be seen in the treated areas when brought in on infested animals or when adults emerge from pupal cases; however, a population will not develop in the treated area. Areas which could be infested include rugs, carpets, upholstered furniture, pet beds and pet resting areas. When treating upholstered furniture, treat under cushions and areas where flea development occurs.

NOTICE: This product has been tested on several types of carpet, fabric and other household furnishings without adverse effects. Test in an inconspicuous area before full treatment, some plastics or furniture may be whitened or dulled. Because of the wide variety of floor types and finishes always test for color fastness, or dulling before applying to larger areas. Avoid contact with antique finishes. For best results always follow complete application directions.

EXCEPT FOR APPLICATOR, DO NOT PERMIT HUMANS OR PETS TO CONTACT TREATED SURFACES UNTIL THE SPRAY HAS DRIED.

[A 20 oz. can treats up to 1,000 sq.ft.] or [A 10 oz. can treats up to 500 sq. ft.] or [A 32 oz. can treats up to 1,600 sq. ft.] Vacuum carpeted areas and other areas being treated before treatment and post treatment after drying. Hold can at arm's length and direct spray toward the area to be treated. Use a sweeping motion to apply product and back away from treated area while holding the can 36 inches away from the area being treated. An area of 100 sq. ft. (10 ft. x 10 ft.) can be treated by spraying across the area for 10 seconds. Vacate treated areas during application up until the spray has dried.

- To Kill Adult Fleas, Brown Dog Ticks and Lone Star Ticks: Remove old companion animal (pet) bedding and replace with fresh, clean bedding after treatment.
- Treat pets with a registered product labeled for flea killer in conjunction with this treatment.
- Do not apply this product directly to companion animals (pets).
