DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted-entry interval (REI) of 12 hours.

NON-AGRICULTURAL USE REQUIREMENTS

The requirements in this box apply to uses of this product that are not within the scope of the Worker Protection Standard for agricultural pesticides, 40 CFR Part 170.

The WPS applies when the product is used to produce agricultural plants on farms, forests, nurseries, or greenhouses.

Do not enter or allow others to enter the treated area until sprays have dried.

APPLICATION INSTRUCTIONS, PRECAUTIONS, AND RESTRICTIONS-ALL LABELED USES

Quali-Pro Chlorothalonil 500 ZN is a flowable fungicide containing chlorothalonil to be used as a spray for the control of many important plant diseases.

Quali-Pro Chlorothalonil 500 ZN is intended to be diluted with water and can be used effectively in dilute or concentrate sprays. Thorough, uniform coverage is essential for disease control. Spray volume to be used varies with the crop and amount of plant growth at the time of application. Both ground and aircraft methods of application are allowed, unless specific directions are given for a crop. The spray volume to be used varies with crop and amount of plant growth; spray volume should normally range from 20 to 150 gallons per acre for dilute sprays and 5 to 10 gallons per acre for concentrate ground sprays and aircraft applications.

The required amount of Quali-Pro Chlorothalonil 500 ZN should be added slowly into the spray tank during filling. With concentrate sprays, premix the required amount of Quali-Pro Chlorothalonil 500 ZN in a clean container and add to the spray tank as it is being filled. Keep agitator running when filling spray tank and during spray operations. When tank mixing this product, observe the most restrictive label precautions and restrictions of the tank mix partner(s). Follow the proper sequence of adding products to the spray tank; add wettable powders or water dispersible granules to the spray tank first, followed by flowable products, then emulsifiable concentrates. Do not combine Quali-Pro Chlorothalonil 500 ZN in a spray tank with pesticides, surfactants, or fertilizers unless prior use has shown the combination to be physically compatible, effective, and noninjurious under your conditions of use. Do not combine Quali-Pro Chlorothalonil 500 ZN with DiPel®, Latron® AG-98, Latron B-1956, Triton® AG-98, Triton B-1956, as phytotoxicity may result from the combination when applied to crops listed on this label. Do not tank mix Quali-Pro Chlorothalonil 500 ZN with oil or any adjuvants which contain oil as their primary ingredient. Do not use Copper-Count® N in concentrated spray suspensions. Tank mixes with products

containing the active ingredient fosetyl-al such as Quali-Pro Fosetyl Al 80 WDG or Chipco[®] Signature[®] can result in physical antagonism if not mixed properly; always fill the spray tank with water to near capacity first. Then, with the agitator running, add the desired amount of Quali-Pro Chlorothalonil 500 ZN followed by the desired amount of product containing fosetyl-al.

Dosage rates on this label indicate pints of Quali-Pro Chlorothalonil 500 ZN per acre, unless specified otherwise. Under conditions favoring disease development, the high rate specified and shortest application interval should be used.

For each listed crop, the maximum total amount of chlorothalonil active ingredient per acre (LB Al/A) which may be applied to that crop or crop group during each growing season is given in bold print within the box below the crop name. For each crop use situation listed on the label, the stated maximum individual and seasonal application rates must not be exceeded and the stated minimum re-treatment intervals must not be decreased.

Do not use on greenhouse-grown crops except as directed in the **ORNAMENTAL PLANTS** section of this label.

For Agricultural Use Sites Only (such as sod farms, farms, forests, nurseries, and greenhouses): This product must not be applied within 150 feet for aerial and air-blast applications or 25 feet for ground applications of marine/estuarine water bodies unless there is an untreated buffer area of that width between the area to be treated and the water body.

Do not use on home lawns and turf sites associated with apartment buildings, daycare centers, playgrounds, playfields, recreational park athletic fields, athletic fields located on or next to schools (i.e., elementary, middle, and high schools), campgrounds, churches, and theme parks.

RESISTANCE MANAGEMENT

Quali-Pro Chlorothalonil 500 ZN is an excellent disease control agent when used according to label directions for control of a broad spectrum of plant diseases. Quali-Pro Chlorothalonil 500 ZN used in programs that are compatible with the principles of Integrated Pest Management (IPM), which include the use of disease-resistant crop varieties, cultural practices, pest scouting, disease forecasting systems, will reduce unnecessary pesticide applications.

Quali-Pro Chlorothalonil 500 ZN is effective for use in programs that attempt to minimize disease resistance to fungicides. Quali-Pro Chlorothalonil 500 ZN has a multi-site mode of action and may be used to delay or prevent the development of resistance to single-site fungicides. Consult with your Federal or State Cooperative Extension Service representatives for guidance on the proper use of Quali-Pro Chlorothalonil 500 ZN in programs that seek to minimize the occurrence of disease resistance to other fungicides.

SPRAY DRIFT MANAGEMENT

Avoiding spray drift at the application site is the responsibility of the applicator. The interaction of many equipment- and weather-related factors determines the potential for spray drift. The applicator and grower are responsible for considering all these factors when making decisions.

The following drift management requirements must be followed to avoid off-target drift movement from aerial applications to agricultural field crops. These requirements do not apply to forestry applications, public health uses, or to applications using dry formulations.

- 1. The distance of the outermost nozzles on the boom must not exceed ¾ the length of the wingspan or rotor.
- 2. Excluding helicopters, nozzles must always point backward parallel with the airstream and never be pointed downward more than 45 degrees.

Where states have more stringent regulations, they must be observed. The applicator should be familiar with and take into account the information covered in the **AERIAL DRIFT REDUCTION ADVISORY INFORMATION** section of this labeling below.

AERIAL DRIFT REDUCTION ADVISORY INFORMATION INFORMATION ON DROPLET SIZE

The most effective way to reduce drift potential is to apply large droplets. The best drift management strategy is to apply the largest droplets that provide sufficient coverage and control. Applying larger droplets reduces drift potential, but will not prevent drift if applications are made improperly or under unfavorable conditions (see **WIND**, **TEMPERATURE AND HUMIDITY** sections).

CONTROLLING DROPLET SIZE

- Volume-Use high flow rate nozzles to apply the highest practical spray volume. Nozzles with higher rated flows produce larger droplets.
- **Pressure**-Do not exceed the nozzle manufacturer's recommended pressures. For many nozzle types, lower pressure produces larger droplets. When higher flow rates are needed, use higher flow rate nozzles instead of increasing pressure.
- Number of nozzles-Use the minimum number of nozzles that provide uniform coverage.
- Nozzle orientation-Orienting nozzles so that the spray is released parallel to the airstream produces larger droplets than other orientations and is the recommended practice. Significant deflection from horizontal will reduce droplet size and increase drift potential.
- **Nozzle type-**Use a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angles produce larger droplets. Consider using low-drift nozzles. Solid-stream nozzles oriented straight back produce the largest droplets and the lowest drift potential.

BOOM LENGTH

For some use patterns, reducing the effective boom length to less than ¾ of the wingspan or rotor length may further reduce drift without reducing swath width.

APPLICATION HEIGHT

Applications should not be made at a height greater than 10 feet above the top of the largest plants unless a greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets to evaporation and wind.

SWATH ADJUSTMENT

When applications are made with a crosswind, the swath will be displaced downwind. Therefore, on the upwind and downwind edges of the field, the applicator must compensate for this displacement by adjusting the path of the aircraft upwind. Swath adjustment distance should increase with increasing drift potential (higher wind, smaller drops, etc.).

WIND

Drift potential is lowest between wind speeds of 2 to 10 mph. However, many factors, including droplet size and equipment type determine drift potential at any given speed. Application should be avoided below 2 mph due to variable wind direction and high inversion potential. Note: Local terrain can influence wind patterns. Every applicator should be familiar with local wind patterns and how they affect spray drift.

TEMPERATURE AND HUMIDITY

When making applications in low relative humidity, set up equipment to produce larger droplets to compensate for evaporation. Droplet evaporation is most severe when conditions are both hot and dry.

TEMPERATURE INVERSIONS

Applications should not occur during a temperature inversion because drift potential is high. Temperature inversions restrict vertical air mixing, which causes small suspended droplets to remain in a concentrated cloud. This cloud can move in unpredictable directions due to the light variable winds common during inversions. Temperature inversions are characterized by increasing temperatures with altitude and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Their presence can be indicated by ground fog; however, if fog is not present, inversions can also be identified by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

SENSITIVE AREAS

The pesticide should only be applied when the potential for drift to adjacent sensitive areas (e.g., residential areas, bodies of water, known habitat for threatened or endangered species, nontarget crops) is minimal (e.g., when wind is blowing away from the sensitive areas).

APPLICATION AND CALIBRATION TECHNIQUES FOR CHEMIGATION

Apply this product only through center pivot, motorized lateral move, traveling gun, solid set, and portable (wheel move, side roll, end tow, or hand move) irrigations system(s). Do not apply this product through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service Specialists, equipment manufacturers, or other experts.

Do not apply this product through irrigation systems connected to a public water system. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

Controls for both irrigation water and pesticide injection systems must be functionally interlocked so as to automatically terminate pesticide injection when the irrigation water pump motor stops. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

The irrigation water pipeline must be fitted with a functional, automatic, quick-closing check valve to prevent the flow of treated irrigation water back toward the water source. The pipeline must also be fitted with a vacumn relief valve and low-pressure drain, located between the irrigation water pump and the check valve, to prevent back-siphoning of treated irrigation water into the water source.

Always inject Quali-Pro Chlorothalonil 500 ZN into the irrigation water after it discharges from the irrigation pump and after it passes through the check valve. Never inject pesticides into the intake line on the suction side of the pump.

Pesticide injection equipment must be fitted with a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump. Interlock this valve to the power system, so as to prevent fluid from being withdrawn from the chemical supply tank when the irrigation system is either automatically or manually turned off.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.

The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Quali-Pro Chlorothalonil 500 ZN may be used through two basic types of sprinkler irrigation systems as noted in Sections **A.** and **B.** below. Determine which type of system is in place and then refer to the appropriate directions provided for each type.

A. Center Pivot, Motorized Lateral Move, and Traveling Gun Irrigation Equipment

For injection of pesticides, these continuously moving systems must use a positive displacement injection pump of either diaphragm or piston type, constructed of materials that are compatible with pesticides, capable of being fitted with a system interlock, and capable of injection at pressures approximately two to three times those encountered within the irrigation water line. Venturi application units cannot be used on these systems.

Fill chemical supply tank of injection equipment with water. Operate system for one complete revolution or run across the field, measuring time required, amount of water injected, and acreage covered. Thoroughly mix labeled amount of Quali-Pro Chlorothalonil 500 ZN for acreage to be covered into same amount of water used during calibration and inject into system continuously for one revolution or run. Mixture in the chemical supply tank must be continuously agitated during the injection run. Shut off injection equipment after one revolution or

run, but continue to operate irrigation system until Quali-Pro Chlorothalonil 500 ZN has been cleared from last sprinkler head.

B. Solid Set and Portable (Wheel Move, Side Roll, End Tow, or Hand Move) Irrigation Equipment With stationary systems, an effectively designed in-line venturi applicator unit is preferred which is constructed of materials that are compatible with pesticides; however, a positive-displacement pump can also be used.

Determine acreage covered by sprinkler. Fill tank of injection equipment with water and adjust flow to use contents over a 30- to 45-minute period. Mix desired amount of Quali-Pro Chlorothalonil 500 ZN for acreage to be covered with water so that the total mixture of Quali-Pro Chlorothalonil 500 ZN plus water in the injection tank is equal to the quantity of water used during calibration, and operate entire system at normal pressures recommended by the manufacturer of injection equipment used for amount of time established during calibration. Agitation is suggested. Quali-Pro Chlorothalonil 500 ZN can be injected at the beginning or end of the irrigation cycle or as a separate application. Stop injection equipment after treatment is completed and continue to operate irrigation system until Quali-Pro Chlorothalonil 500 ZN has been cleared from last sprinkler head.

TURFGRASSES

Do not use on home lawns and turf sites associated with apartment buildings, daycare centers, playgrounds, playfields, recreational park athletic fields, athletic fields located on or next to schools (i.e., elementary, middle, and high schools), campgrounds, churches, and theme parks.

Sod farm turf treated with chlorothalonil prior to harvest must be mechanically cut, rolled, and harvested. Do not use on sod farms at application rates greater than 13 pounds of active ingredient per acre (Al/A) per year. Do not apply more chlorothalonil active ingredient from all registered product sources to the indicated types of turfgrass in the table above.

Apply Quali-Pro Chlorothalonil 500 ZN in 30 to 100 gallons of water per acre on fairways, lawns, ornamental turfgrass, and other turfgrass including sod farms. Apply Quali-Pro Chlorothalonil 500 ZN in 90 to 450 gallons of water per acre on golf course greens and tees. Begin applications when conditions favor disease development and repeat applications as long as these conditions persist. Under severe disease conditions, use the highest rate and the shortest re-treatment interval corresponding with the application schedule selected from the table below. Do not mow or irrigate after treatment until spray deposit on turfgrass is dry. Always use Quali-Pro Chlorothalonil 500 ZN in conjunction with good turf management practices. Do not apply Quali-Pro Chlorothalonil 500 ZN through irrigation systems on golf courses. Apply with ground equipment only. The minimum re-treatment interval for single application rates up to 14 pts./acre (5.0 fl. oz./1000 sq. ft.) of Quali-Pro Chlorothalonil 500 ZN (7.3 LB Al/A) is 7 days. The maximum single application rate for all types of turfgrass including sod farms is 21.6 pts./acre (11.3 LB Al/A). Do not use Quali-Pro Chlorothalonil 500 ZN on fine fescue turf due to the potential for phytotoxicity or turfgrass injury.

Gray Snow Mold caused by *Typhula* spp.: Apply in sufficient water to obtain adequate coverage (2-10 gallons per 1000 square feet). Apply a single application of 8.0 fluid ounces of Quali-Pro Chlorothalonil 500 ZN per 1000 square feet of turf area (21.6 pints per acre). Application must be made before snow cover in autumn. If snow cover is intermittent or lacking during the winter, reapply at monthly intervals until Gray Snow Mold conditions no longer prevail. In areas where Pink Snow Mold (Microdochium or Fusarium Patch) is likely to occur, apply a single application of Quali-Pro Chlorothalonil 500 ZN at 8.0 fluid ounces in combination with products containing iprodione at 2.0 ounces active ingredient per 1000 square feet of turf area. Read and observe all label directions for products containing this active ingredient.

Fusarium (Microdochium) Patch: For control of Fusarium Patch only in areas where snow cover is intermittent or lacking during the winter, apply 8.0 fluid ounces of Quali-Pro Chlorothalonil 500 ZN per 1000 square feet (21.6 pints per acre). Begin applications in late autumn and reapply at 21- to 28-day intervals until conditions favorable for Fusarium Patch no longer prevail.

Algae: For all types of turf, for the prevention of algae on turfgrasses, apply Quali-Pro Chlorothalonil 500 ZN at a rate of 8-14 pints per acre (3-5 fluid ounces per 1000 square feet)(4.16-7.3 LB Al/A) on a 7- to 14-day schedule. Under severe algae conditions, use the 14 pint rate and apply on a 7-day schedule.

When algae is well established, ever attempt should be made to dry out the afflicted area. Once dry, spiking or verticutting should be done to enhance turfgrass recovery in conjunction with Quali-Pro Chlorothalonil 500 ZN application at the rate of 16-21.6 pints per acre (6-8 fluid ounces per 1000 square feet)(8.32-11.3 LB Al/A). On golf course greens and tees, apply a second application of Quali-Pro Chlorothalonil 500 ZN at the 21.6 pint rate 14 days after the first application. Only a preventative spray program with Quali-Pro Chlorothalonil 500 ZN will prevent a recurrence of the algae when environmental conditions are favorable for algal growth.

Prior to commercial use, apply the labeled rates to a small area of plants in question, i.e., bedding plants, foliage, etc., and observe for 7 to 10 days prior to treatment of a commercial crop. Applications made during bloom can damage flowers and/or fruits. Knock-Out® and Double Delight® roses can be

sensitive to Quali-Pro Chlorothalonil 500 ZN resulting in damage to foliage under certain growing conditions. Do not apply Quali-Pro Chlorothalonil 500 ZN to either green or variegated Pittosporum or to Schefflera, as multiple applications have been demonstrated to cause phytotoxic responses.
