The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

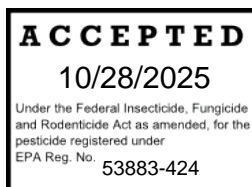

Apply this product to areas frequented by listed cockroaches, their harborage sites, indoors, and/or outdoors. Apply bait where listed cockroaches are suspected or observed, including between different elements of construction, entry points, between equipment and floors, voids, openings leading into voids, and hollow spaces in floors, walls, ceilings, equipment legs and bases, around plumbing pipes, doors and windows, and behind and under appliances, cabinets, sinks, closets, and any other equipment or furniture where cockroaches are typically known to hide. ### **USE DIRECTIONS**

This product can be used in and around residential areas, food/feed establishments, both non-food/non-feed areas and food/feed areas of institutional, warehousing and commercial establishments, including warehouses, restaurants, food processing plants, supermarkets, hospitals, nursing homes, motels, hotels, apartment buildings, bakeries, beverage plants, breweries, bottling facilities, candy plants, canneries, cereal processing and manufacturing plants, dairies and dairy product processing plants, frozen food plants, schools, daycares, laboratories, computer facilities, floor drains (sewers), airports, aircraft, buses, boats/ships, trains, homes, houses, industrial buildings, office buildings, kennels, kitchens, manufacturing facilities, spice plants, stores, wineries and similar structures, mausoleums, meat processing and packaging plants, meat and vegetable canneries, pet shops, and zoos.

- Do not apply bait gel to areas which have been recently sprayed with a repellent insecticide, and do not spray insecticide over gel as it may cause the bait to become repellent.
- **DO NOT USE IN AREAS EASILY ACCESSIBLE TO CHILDREN AND PETS.**
- Do not apply bait to areas that are routinely washed such as cracks and crevices in tops of tables, food/feed preparation surfaces, and prepared food holding surfaces as bait may be removed by washing.

#### **HOW TO APPLY (DIRECTLY FROM SYRINGE):**

Cockroaches prefer pressure on two sides of their body and spend 75% of their existence hiding in cracks and crevices. For this reason, syringe applications directly in cracks and crevices [will go a long way in eradicating the cockroach population] [is an effective way to kill cockroach infestations].

For light to moderate infestations, apply 1 to 3 spots of this gel bait per 10 linear feet or one square yard. For heavy infestations, use 3 to 5 spots of gel bait per 10 linear feet or one square yard. Each bait spot should equal about 0.5 grams (1/4" diameter spot).

Inspect placements of gel bait periodically and apply fresh bait as needed.

For bait spots:

- Remove cap from [syringe] [bait applicator] tip.
- Place [syringe] [bait applicator] tip at the surface to be treated.
- Apply light pressure to [the plunger of the syringe] [dispense].
- After dispensing gel bait, replace the cap [on [syringe] tip].

**Wax Paper Application:** Wax Paper Application: For application in areas such as under appliances or in similar areas, apply the bait using 2-3" wax paper squares at the rate of 0.5 grams per spot, and fold the wax paper over the bait.
