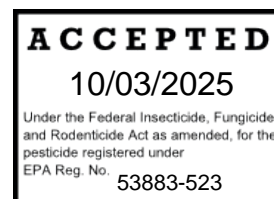

PRODUCT INFORMATION

This product is a ready-to-use dry flowable bait containing the active ingredient Chlorfenapyr. This bait is intended for application with the supplied applicator/the Precision Delivery System [and] [or] [other] [re-fillable] [dust] [applicators]. This product may be used indoors and limited outdoor applications to control a wide variety of pests. *{Note to reviewer: One of the delivery options in bracketed text in section above will be printed on the final printed label.}*

{Note to reviewer: One or the other Application Instructions below will be printed on the final printed label.}

{Note to reviewer: These directions will be used when packaged in puffer tubes}

Application Instructions:

- [Unscrew] [Pull off] the cap.
- Let the hand duster lie across your finger with your palm facing upwards.
- While holding the hand duster parallel to the floor and pointed away from you, begin to lightly shake the tube and push down once per desired bait point.
- Continue to shake the tube between each “puff” to keep the powder in airborne state.
- For your first application, give the tube a few shakes, then a light but firm press of the thumb.
- As the tube starts to empty, gradually begin tilting it downward, continuing the shaking technique and the parallel to gradual tilting of the tube, allowing for peak efficiency.]

{Note to reviewer: These directions will be used when packaged in cartridges for use with the Precision Delivery System Applicator}

Applicator Instructions for the Precision Delivery System™ (PDS):

1. Insert the battery into the Precision Delivery System prior to loading dry flowable products.
2. To insert the 9V battery, unscrew the small screw on the back ledge/underside of top of the PDS unit. The top cover will lift off. Place the 9V battery into the housing as indicated and replace the top cover. Tighten the cover back down with the screw.
3. To load bait into the Precision Delivery System (PDS), remove bait [cartridge] [canister] from packaging and unscrew the lid. [Remove protective film and] firmly screw the bait [canister] [cartridge] into the underside of the PDS. Be sure to keep the bait [cartridge] [canister] upright

to prevent spillage, and **DO NOT** overtighten. Retain the [cartridge] [canister] lid for storage after application is complete.

4. Insert the [appropriate] application straw into the opening on front of the PDS. **DO NOT** use PDS unit without an application straw.
5. Move the switch, located on the back of the PDS to “on”.
6. To dispense bait, insert the [appropriate] application straw into the desired crack, crevice or void. Depress the trigger for the appropriate amount of time. The trigger can be held down to dispense a continuous flow of bait material into a large void if necessary.
7. To replace an empty bait cartridge, unscrew the used cartridge and dispose of it as directed.
8. Bait dispenses at a rate of approximately 0.05 grams per 3 seconds of trigger activation time. Each [cartridge] [canister] contains 5 grams of bait and will provide between 33-100 bait placements per [cartridge] [canister] depending on the application time (See Table below).]

Application Rates and Directions:

The amount of bait applied will vary by site, pest species, and infestation level.

Apply lightly and uniformly to infested areas, foraging trails, harborage sites, and other areas where insect activity is observed or suspected. Pay particular attention to cracks and crevices, service ducts, false floors and ceilings, wall voids, around electrical and telephone fittings and equipment, around water and sewer pipes, under and behind cabinets, refrigerators, dishwashers, other installed appliances and sinks, around window and door frames, and in attics and crawl spaces. For light infestations, place bait in harborage areas, cracks and crevices with a minimum of 5-7 bait placements per 100 ft². For heavy infestations, treat harborage, cracks and crevices with a minimum of 10-20 bait placements per 100 ft². During follow-up visits, inspect the baited areas and reapply when necessary.

For void applications, insert application straw into the void and dispense bait for 3 to 8 seconds. For smaller voids, or light infestations, use the lower end of the specified rate range. For large voids, or heavy infestations, use the upper end of the specified rate range.

[The amount to be applied will vary with the site and infestation level. Applications should be made to sites where insect activity has been observed. For light infestations, a minimum of 4 - 6 bait points is recommended per 100 ft² treatment area. For heavy infestations, a minimum of 12 -24 bait points is recommended per 100 ft² of treatment area. One bait point is equal to 0.15 grams of product (the highest use rate). During follow-up visits, inspect the baited area and reapply when necessary.]

INDOOR TREATMENTS

SILVERFISH: Apply in cracks and crevices where these pests are found. Treat voids and enclosed locations where these pests are suspected, hide, or are found. Treatment may be made to voids in/near food pantries, kitchen and bathroom cabinets, behind baseboards, around doors, around windows, behind wall paper, in wall voids, ceiling voids, around recessed lighting, in attics, in crawl spaces and other construction voids. During follow up visits, inspect bait placements and reapply when necessary.
