

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

CTA 520

is used in recirculating cooling tower systems and industrial microbiological slime. Prior to the use of CTA 520 in industrial and/or commercial recirculating cooling towers, the towers should be cleaned to remove algal growth, microbiological slime, and other deposits. An initial slug addition of 5.7 to 8.6 fl. oz. of CTA 520 per 1000 gal. of water to provide 30 to 45 ppm based on total weight of water in the tower is recommended.

Make subsequent slug addition of CTA 520 per 1000 gal. of water (CTA 520) every 2 to 5 days. The amount of addition depends upon the relative amount of bacterial growth and microbiological problem. Slug additions should be made to recirculating cooling tower systems.

CTA 520 is used in mist eliminators which maintain effective mist-eliminating components. Clean mist eliminators to remove bacterial slime and other deposits. A slug addition of 17.2 fl. oz. of CTA 520 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. A slug addition of 10.0 to 17.2 fl. oz. of CTA 520 per 1000 gal. of water should be employed every 1 to 5 days, or as needed. The amount of addition depends upon the relative amount of bleedoff and microbiological problem. Slug additions may be made to the sump or the water treatment system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack more than 5 drums. Drums should be placed in overpack drums for disposal. Spills should be cleaned up and disposed of in a sanitary landfill. Keep container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper mixing, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by the above instructions, contact your State Pesticide or Environmental Control Agency, or your EPA Regional Office for guidance.

CONTAINER DISPOSAL:

(1) PLASTIC: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or for disposal in a sanitary landfill, by incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.

(2) METAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or for disposal in a sanitary landfill, or by other procedures approved by state and local authorities.
