DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SPA ALGAE FREE is used to control algae growth in swimming pools, exterior spas, whirlpools, hot tubs, and decorative effectiveness pools, spas, whirlpools, hot tubs, and decorative heavy growth of algae should be cleaned prior to using SPA ALGAE FREE.

For pools having just visible algae growth add an initial dose of SPA ALGAE FREE per 10,000 gallons of water. For treatment of a freshly cleaned pool add initially 41 to 75 fluid ounces of SPA ALGAE FREE per 10,000 gallons of water. Subsequent additions of 13.6 fluid ounces of SPA ALGAE FREE per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains having just visible algae growth require an initial dose of 8 to 12 fluid ounces of SPA ALGAE FREE per 1,000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4 to 8 fluid ounces of SPA ALGAE FREE per 1,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of SPA ALGAE FREE should be made every 5 to 7 days after initial treatment for maintenance. SPA ALGAE FREE is compatible with liquid chlorine products used to treat pools and spas and is effective at controlling algae growth. SPA ALGAE FREE can be used in place of liquid chlorine chemicals and may reduce the amount of those chemicals required. However, do not mix SPA ALGAE FREE with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and discarded with clear water. All pesticides should be kept out of reach of children and away from food.

DISPOSAL: Do not reuse empty container. Wrap container in plastic.
