- 2) Consistent with Registration Eligibility Decisions for Boric Acid and its Sodium Salts. the following changes must be made to the product label:

Revise the "Precautionary Statement" to read as follows:

Hazard to Humans and Domestic Animals
Caution

Harmful if swallowed or inhaled. Causes eye irritation. Avoid contact with eyes or clothing. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

3) The Confidential Statement of Formula is not in compliance with PR Notice 91-2. The nominal concentration of the active ingredient (99.4%) is not in agreement with the label claim nominal concentrate of (98%). Revise your Confidential Statement of Formula, accordingly.
