Add one cup of powder (4oz.) to each pail (5gal.) of mop or rinse water. Dissolve instantly in water. Apply to floor areas only. Make only enough for each application. Designed for use as a supplemental treatment to exterminating service or to M5 Roach Kill. Avoid contamination of feed and foodstuffs. Use daily in areas with severe infestation. In normal use, apply daily for 10-15 days and then every other day thereafter to maintain residual. If use is discontinued for a week, use daily for 10 days thereafter to rebuild residual.

Food areas and Food Serving Areas: Apply only when food is not exposed and facility is not in operation. Avoid treating surfaces likely to be contacted by food.
