

ATTACHMENT TO EPA REGISTRATION NOTICE

The following requirements or revisions apply to the label which was accepted with this registration notice:

1. The registration number which has been assigned to this product must appear on the label as EPA Registration No. 54135-1.
2. You are reminded that the EPA Establishment registration number must appear on the label.
3. The word POISON must be printed in red. However, traditionally most registrants satisfy this requirement by printing the word DANGER, the skull and crossbones symbol, and the word POISON in red.
4. The "Hazards to Humans and Domestic Animals" paragraph should begin with the signal word DANGER such as "DANGER: Corrosive to eyes, skin and. . . ."
5. The net contents should be expressed in largest suitable unit such as "23 pounds," not as 23#.
6. The labels which will be used for this product in channels of trade must reflect these revisions.
7. Five copies of the finished printed labels, as defined in the A-79 enclosure, must be submitted to the Agency before the product is released for shipment to comply with PR Notice 82-2 of June 18, 1982.
8. The finished printed labels must comply with the general labeling requirements of Section 162.10 of Title 40 of the Code of Federal Regulations. If the label does not satisfy these requirements it will be rejected.

For use as a disinfectant and algicide in residential pools by trained and qualified service persons, under the direct supervision and employment of the owner of this registration. The registrant is solely responsible for the safety of the servicing equipment used with this pesticide, and for the repackaging of this gas from large containers into portable cylinders. This registration is not transferable. Each repackager must obtain his own EPA Registration Number for this pesticide for this use, and his own EPA Establishment Number from the U.S. Environmental Protection Agency.

Corrosive to eyes, skin, and mucous membranes in presence of moisture. May be fatal if inhaled. Do not breathe air containing this gas. Do not get in eyes, on skin or clothing.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Do not discharge into lakes, streams, ponds or public waters unless in accordance with an NPDES permit. For guidance contact the regional office of the Environmental Protection Agency.

CHEMICAL & PHYSICAL HAZARDS: Chlorine is a non-flammable gas liquefied under pressure. Do not drop container. Keep away from intense heat and open sunlight. Corrosive to most metals in the presence of moisture.

**DIRECTIONS FOR USE
GENERAL CLASSIFICATION**

It is a violation of federal law to use this product in a manner inconsistent with the labeling. Have available gas masks approved by the U.S. Bureau of Mines or the National Institute for Occupational Safety and Health. Handle and use only in accordance with practice recommended in the Chlorine Manual published by the Chlorine Institute, Inc. New York. Use only in well ventilated areas.

Only specially designed dispensing equipment should be used, in accordance with manufacturer's instructions and with the Chlorine Institute's recommendations. Dosages of residual chlorine levels which should be maintained for any specific site of application must be consistent with recommended practice and state and municipal recommendations.

STORAGE AND DISPOSAL

Keep containers away from heat. Do not store in direct sunlight or drop portable containers.

All storage containers must have a weather resistant label attached near outlet valve and must not be accessible to general public. Empty containers should be properly identified with return tags and returned to supplier according to prescribed instruction and practices recommended by the Chlorine Institute.
