DIRECTIONS FOR USE  
GENERAL CLASSIFICATION

It is a violation of Federal law to use this product inconsistent with its labeling.

MB-103 is used

in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 3.3 MB-103 per 1000

gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.1 MB-103 per 1000 gallons

every 1 to 5 days, or as needed. The frequency and relative amount of bleedoff and the severity of the additions should be made in the sump of water cooling

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are considered hazardous. Pesticide wastes are not to be disposed of by use according to the State Pesticide or Environmental Control Agency. Contact a representative at your EPA Regional Office for guidance.
