It is a violation of Federal law to use this product inconsistent with its labeling.

Bac-Stat ER 80 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 2.6 Bac-Stat ER 80 per 1000

gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 0.85 to Bac-Stat ER 80 per 1000 gallons every 1 to 5 days, or as needed. The frequency of relative amount of bleedoff and the severity of the m additions should be made in the sump of water cooling

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage. **STORAGE:** Do not expose to extreme temperatures. Store five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a container closed when not in use.
