The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Fodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1) If your new labeling will include all information on the front panel, delete the reference, "See back panel for additional precautionary statements".
- 2) The labeling statement, "100% DEET", can not appear in the label ingredient declaration. It may, however, appear elsewhere on the label.
- 3) Check with your supplier concerning the correct signal word to be used for this product.
- 4) According to your Confidential Statement of Formula, the flash point your product is 310 degrees Fahrenheit which would qualify your product not to require a flammability precaution. Explain the reasoning for the "flammable" designation, or delete it from the label.
- 5) Modify all statements denoting "Keep Out of Reach..." to read: "Keep out of reach of children".
