Dear Mr. Dickens:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provisions:

Marketing Claims section comment(s), page 1 of 2:

1. Delete the unquantified duration claim statement "(Long-lasting protection from)."
2. Delete the following insect-borne diseases from the label: (1) Japanese encephalitis; (2) Murray Valley encephalitis; (3) Ross River Fever; (4) Barmah Forest Disease; (5) Yellow Fever; (6) Rift Valley Fever; (7) European Tick Borne encephalitis; and (8) Onchocerciasis. These insect-borne diseases currently do not occur within the continental United States and/or its territories.

Ingredient Statement section comment(s), page 1 of 2:

3. Replace the existing section with the following:

4. Revise the introduction to this section by relocating the first two (2) sentence to their own lines for more prominence as follows:

5. Replace the existing section with the following:


Container Disposal: Triple rinse (or equivalent). Then offer for recycling, or puncture and dispose of in a sanitary landfill, or incineration, etc., or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

The optional marketing claim "Repels mosquitoes that may carry West Nile virus" requires in part the submission of product-specific efficacy data. In accordance with the Agency's January 5, 2004 letter, this data requirement remains applicable. Once the efficacy performance guidelines for repellents are in place, you will be notified of all efficacy data requirements.

Further, to be eligible for reregistration, aerosol and pump spray formulations must be packaged in containers utilizing a concave trigger to help aim the product or another comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

A stamped copy is attached for your records. Please submit two (2) final printed copies of the referenced label, incorporating the above changes, before releasing the product for shipment.
