Apply in early morning or at dusk for best results. Repeat every 24 hours or as directed by a veterinarian. Frequent reapplication and saturation is unnecessary for effectiveness. Do not apply other insecticides or repellents when using this product. Do not spray in enclosed areas. Do not apply under wraps or bandages. Do not apply over cuts, wounds or irritated skin. Do not apply to eyes and mouth. Do not spray directly on face. Wash thoroughly with soap and water after handling. Wash contaminated clothing before reuse.
