in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 6.9

Aquacide 100 \_\_\_\_\_ per 1000

gallons. Repeat initial dosage until control is evident.

Subsequent slug additions of 2.3 to  
Aquacide 100 \_\_\_\_\_ per 1000 gallons

every 1 to 5 days, or as needed. The frequency of relative amount of bleedoff and the severity of the conditions should be made in the sump of water cooling

**STORAGE AND DISPOSAL**
