DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal law to use this product inconsistent with its labeling.

Aquacide 100 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.9 Aquacide 100 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 to Aquacide 100 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

This product contains 0.77 lb. of active ingredients per gallon and weighs 8.81 lb. per gallon.

STORAGE AND DISPOSAL
