DIRECTIONS FOR USE

It is a violation of Federal law to use this product in its labeling.

Aquacide 55 is used in swimming pools, exterior spas, whirlpools, hot tube, and minimum effectiveness pools, spas, whirlpools, hot tube, and heavy growth of algae should be cleaned prior to using Aquacide 55. For pools having just visible algae growth add an initial 41 fluid ounces of Aquacide 55 per 10,000 gallons of water. Subsequent additions of 1 fluid ounces of Aquacide 55 per 10,000 gallons of water 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tube, and decorative fountains require an initial dose of 8 to 12 fluid ounces of Aquacide 55 per 1,000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4 fluid ounces of Aquacide 55 per 1,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of Aquacide 55 should be made every 5 to 7 days after initial treatment for maintenance. Aquacide 55 is compatible with chlorine products used to treat pools, spas, and decorative fountains and alkaline pH. Aquacide 55 can be used on decorative fountains treated with chlorine chemicals and maintenance chemicals normally required. However, do not mix Aquacide 55 with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and discarded with clear water. All pesticides should be kept out of away from food.

DISPOSAL: Do not reuse empty container. Wrap
