

Algae Buster

In swimming pools, exterior spas, whirlpools, hot tubs, indoor effectiveness pools, spas, whirlpools, hot tubs, heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial dose of 6 fluid ounces of Algae Buster to move settled algae debris by cleaning. For treatment of a pool add initially 6 to 11 fluid ounces of Algae Buster per 10,000 gallons of water. Subsequent additions of Algae Buster per 10,000 gallons 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 1 to 2 fluid ounces per 1000 gallons of water. For treatment of a freshly hot tub or decorative fountain, add initially 0 Algae Buster per 1,000 gallons of 0.2 to 0.4 fluid ounces of Algae Buster should be made every 5 to 7 days after initial treatment. Algae Buster is composed of Algae Buster used to treat pools, spas, and decorative fountains with alkaline pH. Algae Buster decorative fountains treated with chlorine chemicals or chemicals normally required. However, do not mix Algae Buster with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and stored with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty container. V
