

in swimming pools, exterior spas, whirlpools, hot tubs, and whirlpool effectiveness pools, spas, whirlpools, hot tubs, and whirlpools, heavy growth of algae should be cleaned prior to use.

For pools having just-visible algae growth add an initial dose of WS_30

fluid ounces of WS_30 per 10,000 gallons of water. For treatment of a free hot tub, or decorative fountain, add initially WS-30 per 1,000 gallons of 0.5 to 0.8 fluid ounces of WS-30 should be made every 5 to 7 days after initial treatment.

7 days after initial treatment for maintenance. Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 2 to 4 fluid ounces per 1000 gallons of water. For treatment of a free hot tub, or decorative fountain, add initially WS-30 per 1,000

gallons of 0.5 to 0.8 fluid ounces of WS-30 should be made every 5 to 7 days after initial treatment. WS-30 is commonly used to treat pools, spas, and decorative fountains with an alkaline pH. WS-30

decorative fountains treated with chlorine chemicals. Chlorine chemicals normally required. However, do not mix with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty containers.
